Hong Kong Family Welfare Society Live Supervision Application Procedures & Charges

- 1. Trainee mediators who apply for live supervision from the Society should satisfy the requirements set out by HKMAAL. (For details, please refer to "HKMAAL" Requirements to be an "Accredited Family Mediator" at www.hkmaal.org)
- 2. Applicants should complete the "Application Form" and send to:

- 3. The applications would be assessed according to the requirements as stated in Clause 1. A written reply will be issued to applicant to inform about the result of the application. <u>Our Society would only arrange one Supervisor to live supervise each eligible trainee.</u> A contract will be signed by the Trainee and the Supervisor at the beginning of live supervision.
- 4. The applicant has the responsibility to commit to the live supervision process, by which at least 4-8 sessions with interval of one to two weeks are expected. Should the applicant turn down the invitation to undergo a live supervision case for twice, he/she will be put into the inactive waiting list, implying that he/she is required to take initiative to contact Senior Coordinator (Mediation Services) of the Society's Mediation Centre to reactivate his application. The Society's Mediation Centre reserves the right to make the final decision on whether to reactivate the application.
- 5. Most live supervision cases require interviews to be conducted during our office hours, i.e. Monday to Friday from 9 a.m. to 5:30 p.m..
- 6. The length of waiting time for live supervision is uncertain. Variables such as language and cultural compatibility, time constraint, availability of suitable cases for live supervision may affect the length of waiting time.
- 7. The supervisee should pay a standard charge of <u>HK\$800 per hour</u> for the live supervision, which will be capped at HK\$14,400 (18 hours) per live supervision.
- 8. Upon termination of each case, the supervisor will complete the "Record of Supervision Hours" for endorsement by the supervisee. A letter will be sent to the supervisee for settlement of the supervision fees as stated in the endorsed "Record for Supervision Hours".
- 9. All payment should be made by cheque and payable to "Hong Kong Family Welfare Society". The payment should be sent to the Senior Coordinator (Mediation Services) who is in-charge of the Mediation Centre at the address as stated in Clause 2.
