Maintenance Mediation Pilot Scheme

計劃背景 Background of the Pilot Scheme

處理離異及贍養費的爭議並不是容易的過程，有部分當事人選擇訴諸法庭以解決相關爭議。除了訴諸法庭之外，調解是另一種有效解決爭議的方法。有見及此，民政及青年事務局透過關愛基金撥款，並委任香港家庭福利會推行為期三年的贍養費調解試行計劃，為正在分居或離婚人士提供與贍養費相關的調解服務，協助雙方就有關事項以調解方式解決爭議。

Resolving disputes related to divorce and maintenance are not easy. Parties involved in maintenance payment disputes might contest the matter in court for dispute resolution. Mediation is an effective alternative way to resolve disputes other than court proceedings. In this regard, the Home and Youth Affairs Bureau launches a three-year Maintenance Mediation Pilot Scheme (Pilot Scheme) through the Community Care Fund, appointing the Hong Kong Family Welfare Society to provide mediation services on maintenance to separating or divorcing persons, so as to assist both parties to resolve related disputes through mediation.



受惠對象及資格 Beneficiaries and Eligibility

試行計劃屬自願參與性質，為正在分居或離婚人士(包括贍養費支付人及受款人)提供與贍養費相關的調解服務。只要涉及贍養費爭議的任何一方(申請人)為香港居民及符合以下資格，雙方均可參與試行計劃，**費用全免**。

Participation in the Pilot Scheme is on a voluntary basis. The Pilot Scheme provides mediation services on maintenance to separating or divorcing persons(including maintenance payers and payees).

Parties involved in maintenance payment disputes are eligible to apply for the Pilot Scheme **free of charge** provided that one of the parties (applicant) is a Hong Kong resident and meets the following criteria.

- 1 申請人為「綜合社會保障援助」(綜援)受助人；或
The applicant is a recipient of the Comprehensive Social Security Assistance (CSSA) Scheme; or
- 2 申請人為在職家庭津貼計劃全額津貼受助人；或
The applicant is a full-rate allowance recipient of the Working Family Allowance Scheme; or
- 3 申請人為學生資助計劃(包括學校書簿津貼計劃／學生車船津貼計劃／上網費津貼計劃)豁免全費受助人；或
The applicant is a full-level assistance recipient of Student Financial Assistance Schemes (including the School Textbook Assistance Scheme / the Student Travel Subsidy Scheme / the Subsidy Scheme for Internet Access Charges); or

- 4 申請人不符合上述(1)至(3)項的資格，但屬低收入家庭，即申請人及與其同住家庭成員的家庭每月入息須不超過以下相關住戶人數的入息上限：(請參考下表)

Applicant not meeting criteria (1) to (3) above but belongs to a low-income family, that is, himself/herself and the household members residing with him/her earn a monthly household income of no more than the specified income limit applicable to the corresponding household size:(Please refer to the table below)

調解範圍 Scope of Mediation

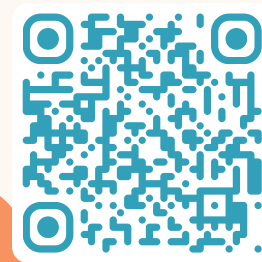
計劃為有需要人士提供與贍養費相關的調解服務。在調解贍養費爭議的過程中，可能會涉及一些與離婚相關的不同範疇(例如分居安排、撫養權、婚姻居所及財產分配安排等)，因此，調解員於調解贍養費爭議的過程中，亦會同時協助調解其他與離婚相關的問題，以期為雙方提供最佳的調解結果。

The Pilot Scheme provides mediation services on maintenance to people in need. During the process of mediation for maintenance disputes, various divorce-related issues may be involved. (e.g. separation arrangements, custody, matrimonial home and arrangement for property distribution, etc.) Therefore, mediators will also assist in mediating other divorce-related issues in parallel to the maintenance mediation process to hopefully achieve the best mediation results for both parties.

申請方法 Application

- 可自行申請或經社工、律師等有關專業人士轉介
Self-application or referral from social workers, lawyers or relevant professionals
- 經香港家庭福利會評估是否合適以調解方式處理後，將為合資格之個案安排調解服務
After assessing the suitability of the applicant's case for mediation by the Hong Kong Family Welfare Society, mediation services will be arranged for eligible cases

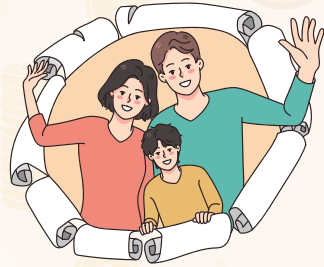

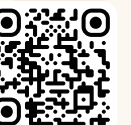
